Exciting Development: GMC UK Now Registers Physician Associates Globally – Expanding Opportunities for Clinical Officers and PA Equivalents!

Dear GACOPA Members,

We are delighted to share a groundbreaking milestone in the recognition and registration of Physician Associates (PAs) globally. The **UK General Medical Council (GMC)** has announced new registration pathways for PAs and comparable professionals from additional countries, including Kenya, Ghana, and others, to apply for GMC registration and practice in the UK. This marks a pivotal moment in our shared mission to advance the harmonization of the PA/Clinical Officer profession worldwide.

Why This Matters:

This decision by the GMC is a testament to the growing recognition of the vital role played by PAs, Clinical Officers, and equivalent professionals in global healthcare systems. It also aligns closely with GACOPA and IAPAE's strategic advocacy for **harmonized education, accreditation, and practice standards** for these professions across borders.

The GMC's new registration framework includes:

1. **Qualification Assessment:** Applicants must provide evidence that their PA qualification meets GMC standards, including in-depth coursework, clinical rotations, and supervision criteria.
2. **English Language Proficiency:** Proof of effective communication skills in English, vital for safe and effective practice.

3. **Registration Assessments:** All applicants must pass the Physician Associate Registration Assessment (PARA), conducted by the Royal College of Physicians.
4. **Recognition of PA Equivalents:** For countries where the PA profession is regulated by law, qualifications will be assessed for parity with UK standards.

Recognized Countries for Registration:

The GMC now recognizes qualifications from the following countries, allowing their PAs and equivalents to apply for registration and practice in the UK:

1. Bangladesh
2. Canada (varies by region)
3. Ghana
4. Iceland
5. Ireland
6. Israel
7. Kenya
8. Liechtenstein
9. Malawi
10. Netherlands
11. Norway
12. South Africa
13. Switzerland
14. USA
15. Zimbabwe

GMC Registration Key Points:

- Registration applications are now open, with qualification assessment fees set at £500.
- English language tests (IELTS/OET) and PARA exams are mandatory for most international applicants.
- A two-year transition period (2024-2026) allows practitioners to meet these requirements while maintaining their current roles.

Global Collaboration and Accreditation:

This development comes as we prepare for the **2025 International Summit** hosted by the American Academy of PAs (AAPA) on **March 21-22, 2025, in Atlanta, Georgia**. This summit will address the feasibility of extending ARC-PA accreditation to international PA programs, opening pathways for graduates to sit for the PANCE exam and earn NCCPA certification.


1. **Apply for GMC Registration:** Eligible members should prepare their documents and apply to the GMC to seize this opportunity.
